

The Property consists of a two story multi-tenant office building measuring +/- 15,185 square feet on a .73 acre lot in the City of Norcross. The Property has consistently maintained high occupancy (currently 92% leased) and tenants' average time of occupancy is 8.5 years. Managed and maintained by a single owner since 2002, the Property is in excellent condition and demised into 15 efficient tenant-friendly layouts. The Property has recently been painted and is being sold with surplus HVAC units.

PROPERTY OVERVIEW


Crossings Center Office Park is a 5 building office park with incredible access to the North Metro area. Each building is privately owned, and the parking lots and landscaping are owned in common. The attractively landscaped setting is located in Norcross (just east of Peachtree Corners) at the intersection of Holcomb Bridge Road and Atlantic Boulevard, one block east of Peachtree Industrial Boulevard. Interstate 285 is 3.5 miles south, Interstate 85 is 2 exits east, and GA 400 is 2 exits west.

The Crossing Center 1 Office Buildings are stylish, highly improved, and well-appointed office buildings with excellent exposure on Holcomb Bridge Road with a traffic count of approximately 15,000 vehicles per day. The Property's flexible zoning (C-2) allows for a variety of uses. The Property's location, finishes and amenities have enabled the buildings to maintain a high occupancy level.









FLOOR PLANS
